Trade Status - Netflix (NFLX)

Hello Vertical Spread Traders,

Let's get an update on our NFLX spread trade that we entered last Friday.

Unfortunately we have not been filled yet.

Our sale price is at \$.25 per spread, and as soon as we placed the order, NFLX (and the rest of the market), started moving higher, then higher again, leaving us in the dust.

It's sometimes really hard to get into these trades when the stock/market gaps higher and then continues to run higher.

I don't really like to chase things because I know we'll get a pull-back, but man, sometimes the FOMO kicks in.

Anyway, NFLX stock is pulling back today, as it's down about \$10 per share.

The spread we're working on is valued near \$.21 to \$.22 per spread, so let's see if this pull-back will go a little deeper, possibly allowing us to get filled at \$.25 per.

I'm tempted to move the strikes up one level, which should be able to get us in at \$.25 per, but I want to see if the pull-back has more to go.

So for now, keep your current order working "GTC" at \$.25 sale price. The instructions are listed below for reference.

Here's what you can chose to do (official):

Sell (sell-to-open) the NFLX April 19, 2024 \$465/\$460 put option credit spread (\$5-wide) for a <u>limit credit sell</u> price of \$.25 per spread or higher, GTC, as an opening transaction (sell-to-open).

Do not sell for anything less than \$.25 per spread.

If you need more details, you can check the alert from last Friday February 23, 2024.

Ok, that's all for now.

Continue to hold all other open positions as-is.
